Internet Services Acceptable Use Policy

- A. Etiquette.** The Olin Telephone Company network and services may only be used in a manner that is consistent with the intended purpose of the Olin Telephone Company network and services may be used only for lawful purposes. Users shall not use the Olin Telephone Company network and services in order to transmit, distribute or store material: (a) in violation of any application law or regulation, including export or encryption laws or regulations; or (b) that may expose Olin Telephone Company to criminal or civil liability; or (c) that constitutes electronic junk mail or newsgroups. Users are further prohibited from assisting any other person in violating any part of the terms and conditions
- B. Inappropriate Content.** Users shall not use the Olin Telephone Company network and services to transmit, distribute or store material that is inappropriate, as reasonably determined by Olin Telephone Company or material that is indecent, obscene, pornographic (including child pornography), defamatory, libelous, threatening, abusive, hateful or excessively violent.
- C. Internet Intellectual Property.** Material accessible through Olin Telephone Company network and services may be subject to protection under privacy, publicity or other personal rights and intellectual property rights including, but not limited to copyrights and laws protecting patents, trademarks, trade secrets or other proprietary information. Users shall not use the Olin Telephone Company network and services in any manner that would infringe, dilute, misappropriate or otherwise violate any such rights. If you use a domain name in connection with any of the Olin Telephone Company network and services, you must not use that domain name in violation of the trademark, service mark or other rights of any third party.
- D. Harmful Content.** Users shall not use the Olin Telephone Company network and services to transmit, distribute or store material that contains a virus, worm, Trojan horse or other component harmful to the Olin Telephone Company network and services, any other network or equipment or other users of the network.
- E. Harmful Materials and Actions.** Customers are prohibited from making available any data, information or other material or engaging in any activity that Olin Telephone Company determines in its sole and exclusive discretion, may expose Olin Telephone Company to civil or criminal liability of any type or otherwise threaten to adversely affect Olin Telephone Company public image, reputation or goodwill. Olin Telephone Company will suspend or terminate, in whole or in part, the service of any customer who's listing by a commonly recognized blacklist threatens to disrupt service to Olin Telephone Company or Olin Telephone Company's customers. Olin Telephone Company may also block any IP address that is listed on any commonly recognized blacklist. Olin Telephone Company network will not open our mail servers to any company that is on a blacklist.
- F. Suspension/Termination.** Any user which Olin Telephone Company determines to have violated any element of the terms and conditions herein may be subject to a suspension or termination of services and if Olin Telephone Company deems it necessary, immediate suspension or termination of such user's service without notice. Olin Telephone Company may take such further action

as Olin Telephone Company determines to be appropriate under the circumstances to eliminate or preclude repeat violations and Olin Telephone Company shall not be liable for any damages of any nature suffered by any customer, user or any third party resulting in whole or in part from Olin Telephone Company exercise of its rights under this paragraph.

- G. Miscellaneous Internet Provisions.** User acknowledges the variety of subject matter and content found on the Internet or World Wide Web and that it is user's responsibility to determine its suitability for members of user's household or business and that some content may not be suitable for viewing by children. User agrees to hold Olin Telephone Company harmless for liability resulting from the subject matter or content found on the Internet or World Wide Web.
- H. Olin Telephone Company may revise, amend or modify the Acceptable Use Policy (AUP) at any time and in any manner.
